- Accept the decisions of your coach - the Management Committee of PUNC fully support and endorse the decisions made by coaches and managers.
- **For Association Registration Cards: All players and/or parents are required to provide consent for PUNC to take a passport photo of each club member when first registering and every 3 years thereafter**

PUNC Club Commitments:

- PUNC covers a number of duties throughout the season that are allocated by the BCNA Executive Committee; including canteen, grounds, tent and tower duties.
- By becoming a member of PUNC you agree to assist the club in fulfilling these duties.
- If you are 14 years and over, you will be allocated a minimum of 3 umpiring duties. Penalties for non-compliance are applicable as per PUNC Operating Procedures.

Statistics:

Any member can request not to receive mail communications that do not directly relate to their participation in programs or their membership.

Disclosure of Membership Information:

NSW Netball Association may facilitate aggregate database access for Netball Australia, sponsors and other relevant interested parties to enable these bodies the opportunity to have mail outs forwarded to members. In such cases member's personal contact information is not provided. Third parties, such as mailing houses, may on the signing of a confidentiality agreement obtain a copy of aggregate data.

'Opt Out':

NSW Netball provides all members the opportunity to 'opt out' of any direct mail out. In such cases the member can elect not to receive further information from NSW Netball.
